This should mean both their individual learning needs as well as their individual personality.</li> <li>To bear in mind the Christian ethos that underpins the life of the school community and bring its values into the classroom.</li> <li>To plan lessons clearly and within the departmental scheme of work</li> <li>To mark work regularly and promptly, in line with departmental and school marking policies and to keep clear and full records of pupils' progress.</li> <li>To insist upon high levels of behaviour and respect for others in the classroom</li> <li>To be a subject expert who regularly updates their knowledge to stay 'current' in their subject.</li> <li>To apply the necessary health and safety procedures when appropriate</li> <li>To contribute to the pastoral care of the pupils, including weekly duties in houses</li> <li>To contribute to extra-curricular activities</li> <li>To adhere to and maintain School Policies and Procedures</li> <li>To take responsibility for safeguarding the pupils</li> <li>To carry out other associated duties as are reasonably assigned by the Head.</li> </ul>
